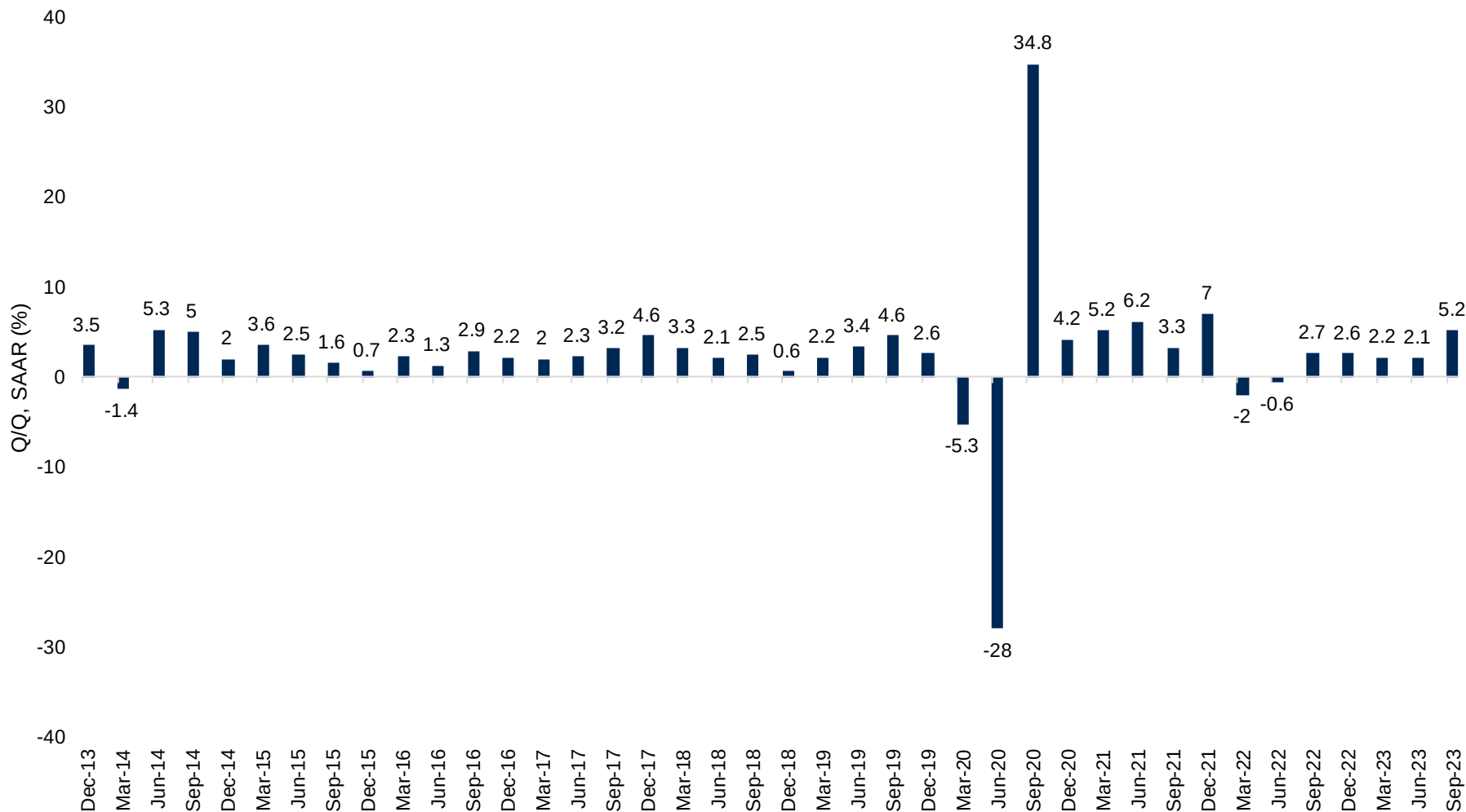

U.S. Real GDP Growth

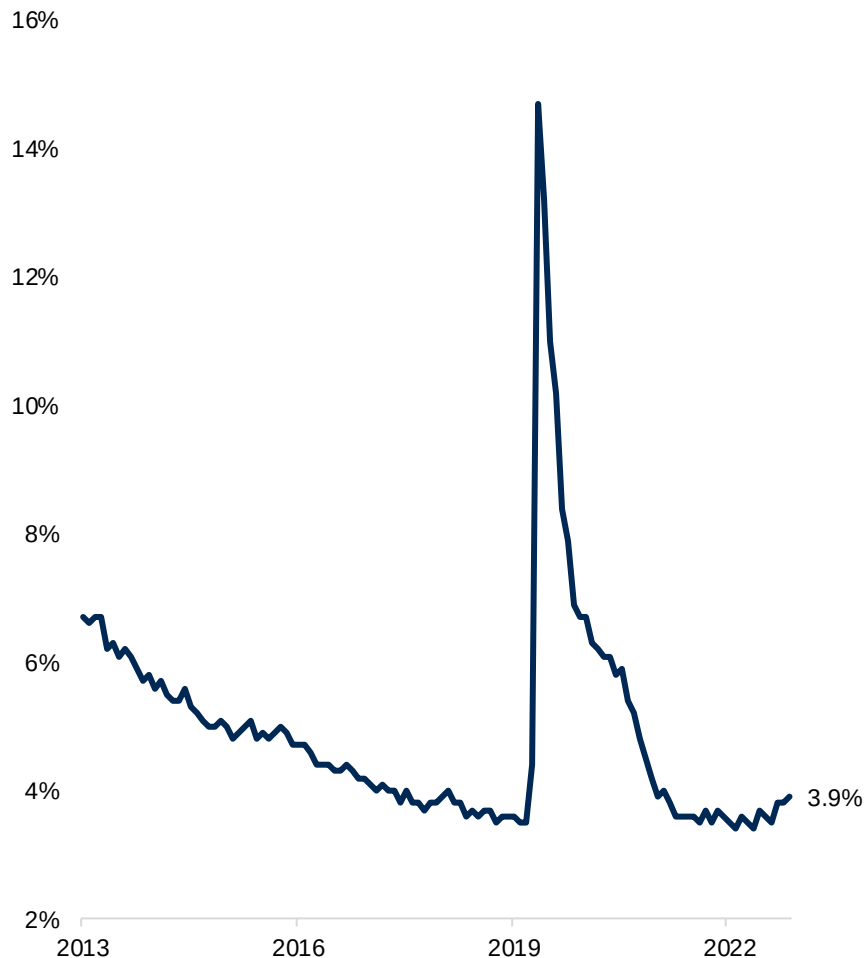

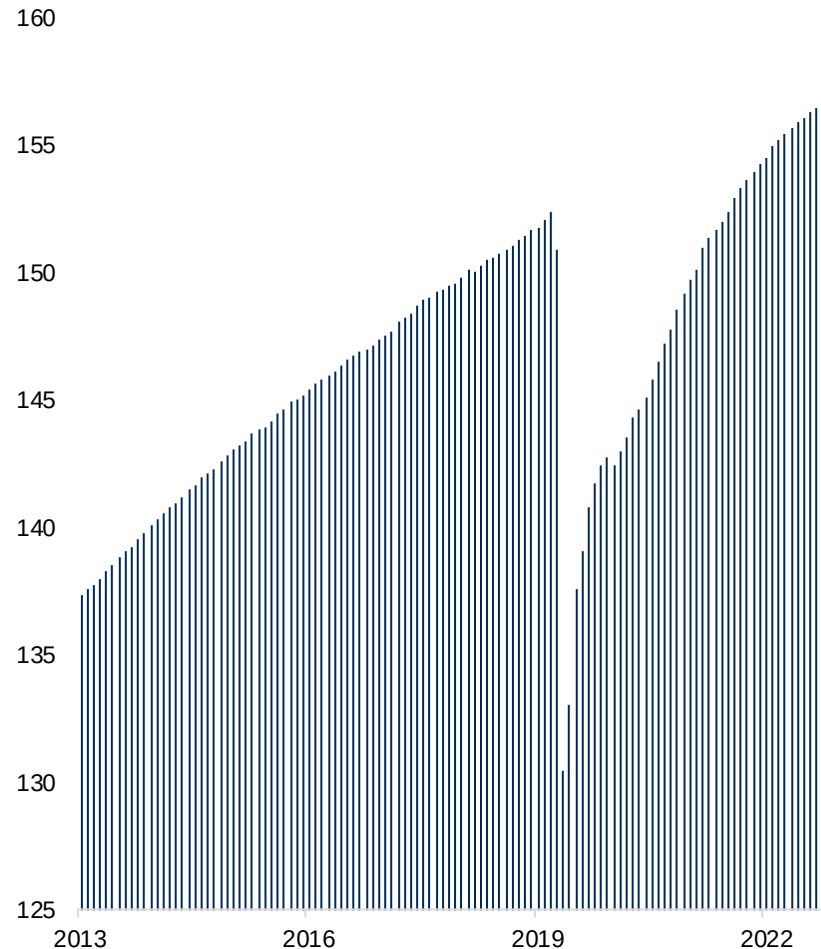


**U.S. Unemployment Rate

(Millions, Seasonally Adj.)**

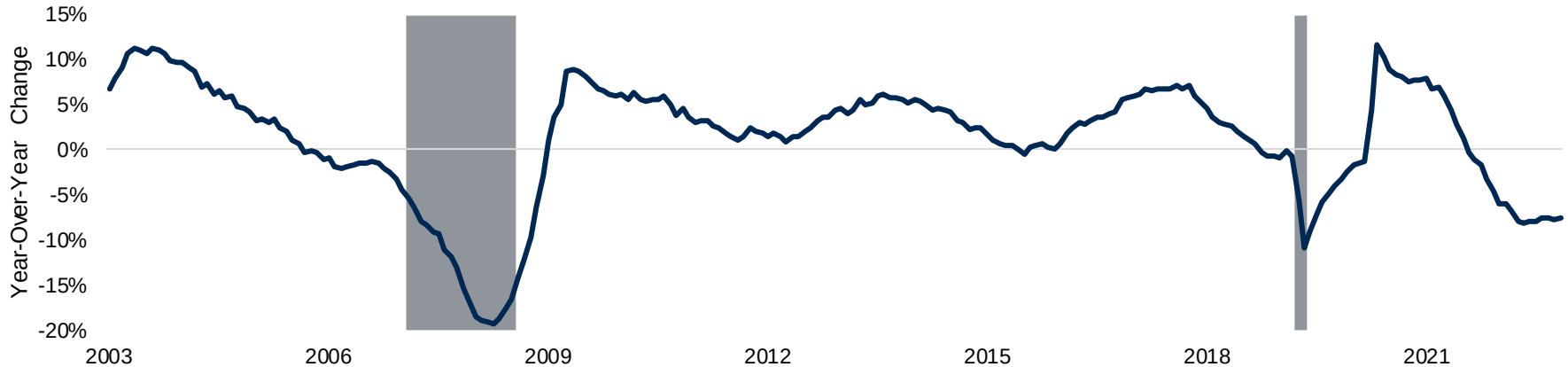

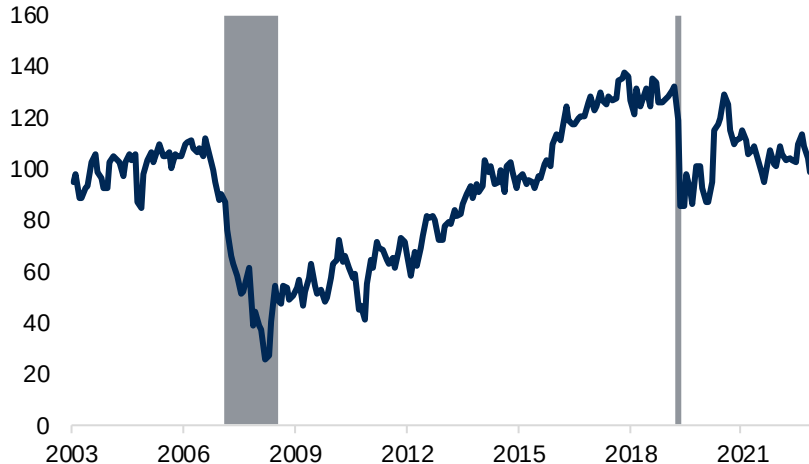


U.S. Leading Economic Indicator Index



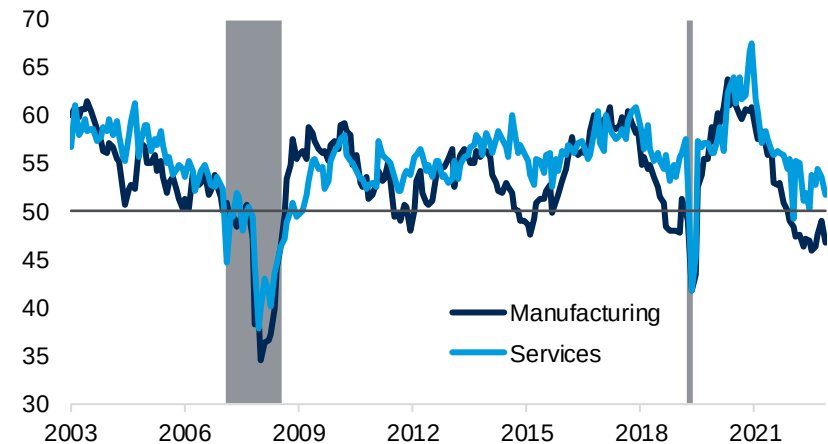

U.S. ISM PMI Levels

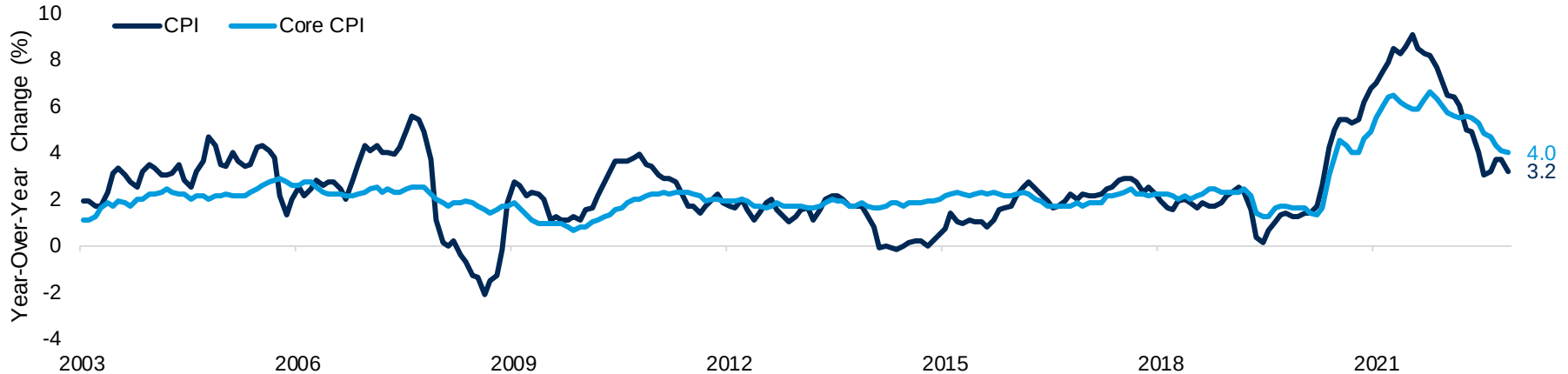

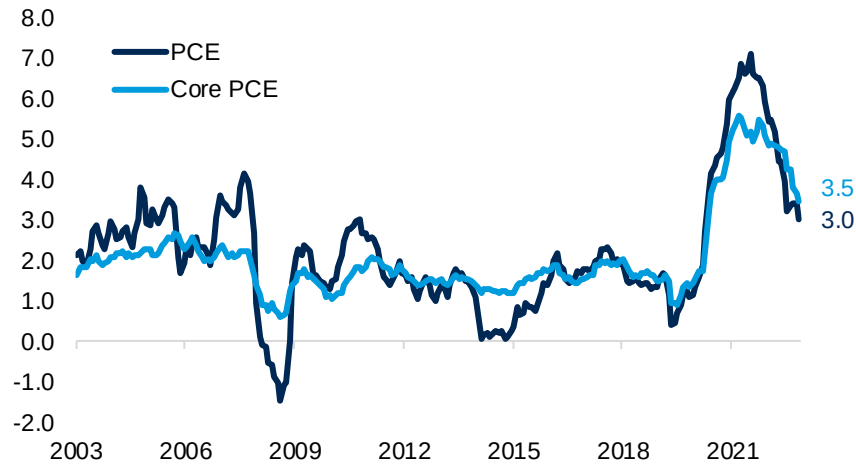


U.S. Consumer Price Index



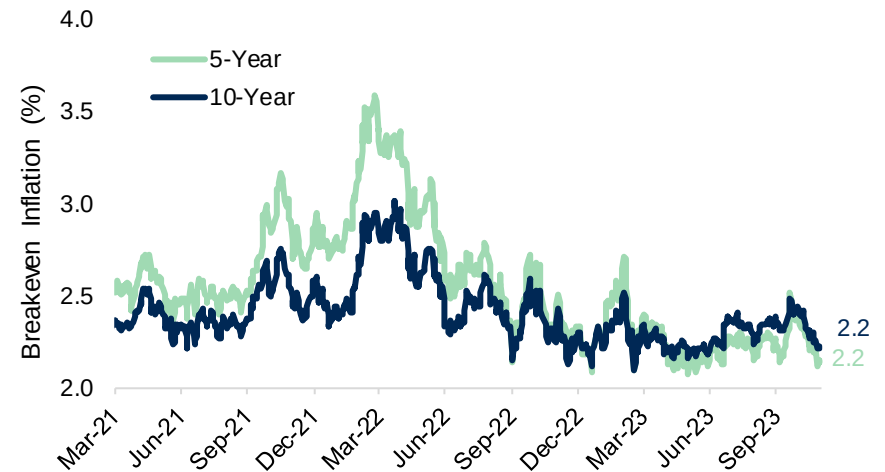

U.S. Breakeven Inflation

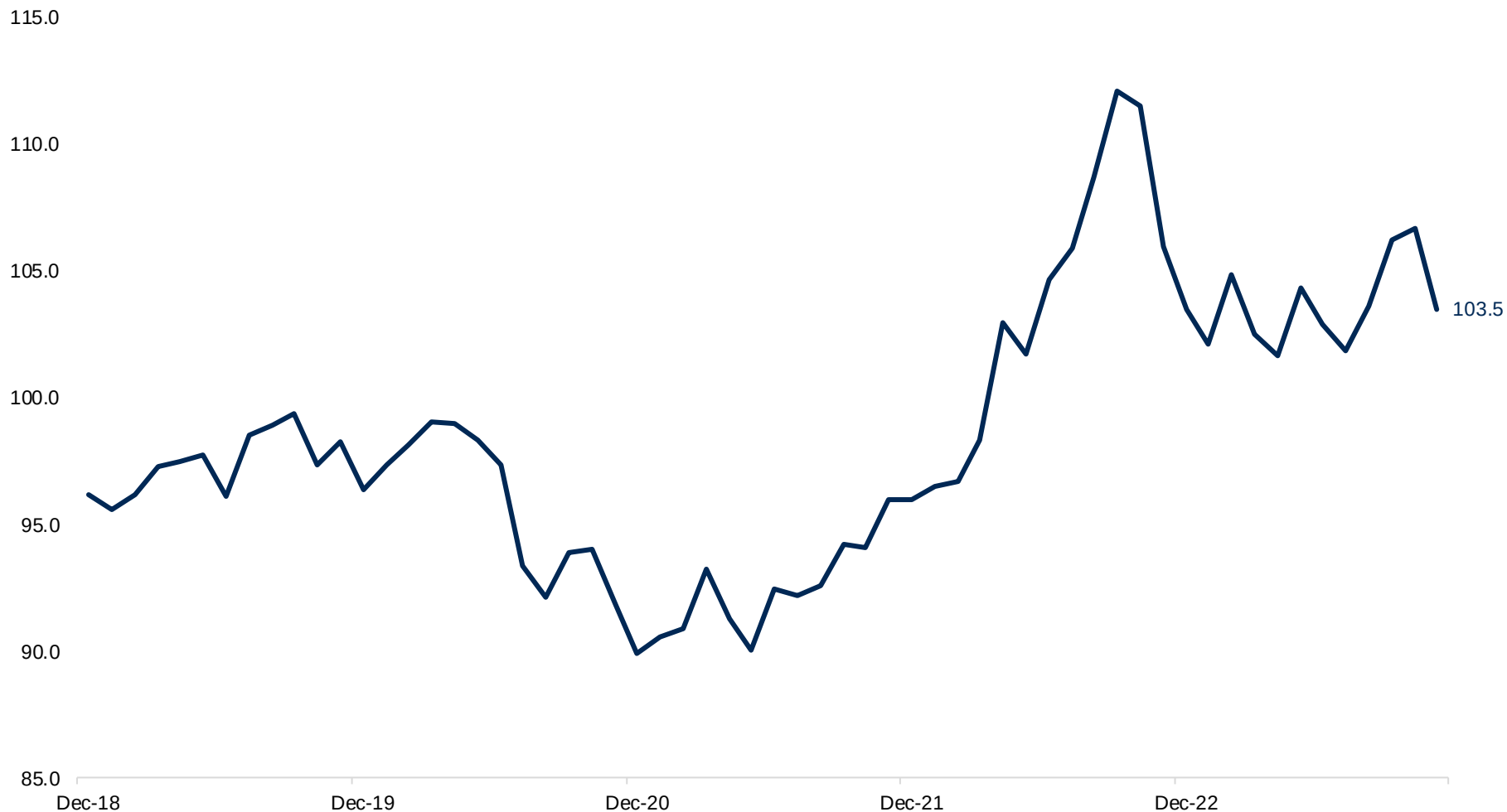

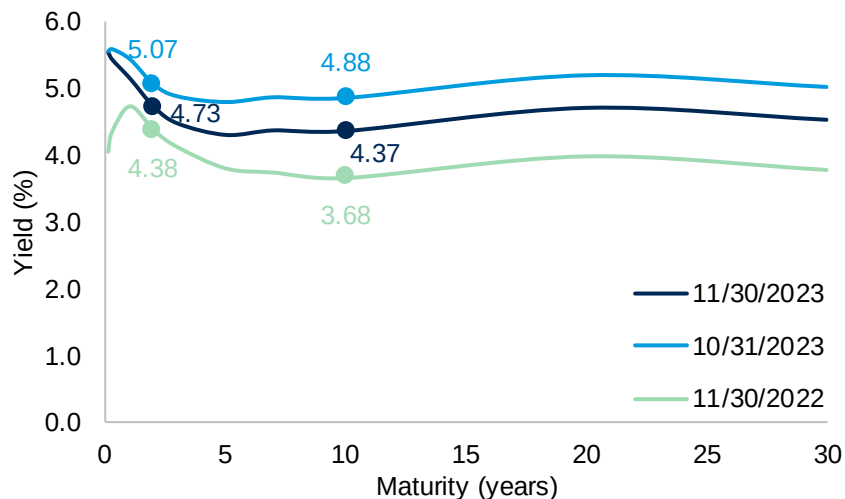

U.S. Treasury Yield Curve



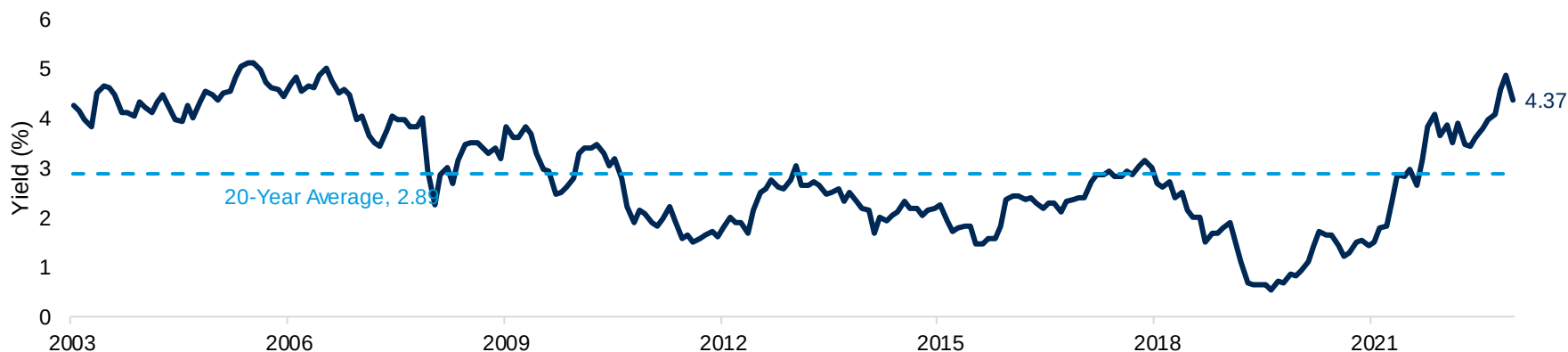

U.S. 10-Year Treasury Yield

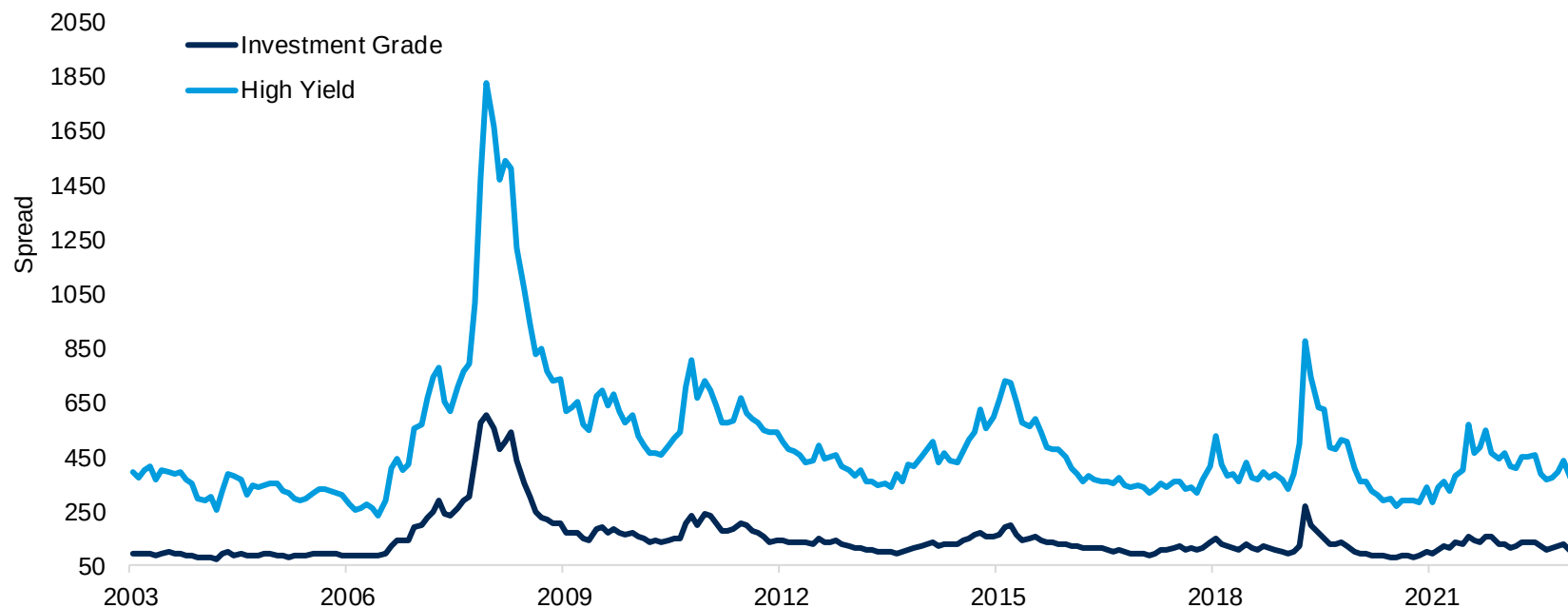

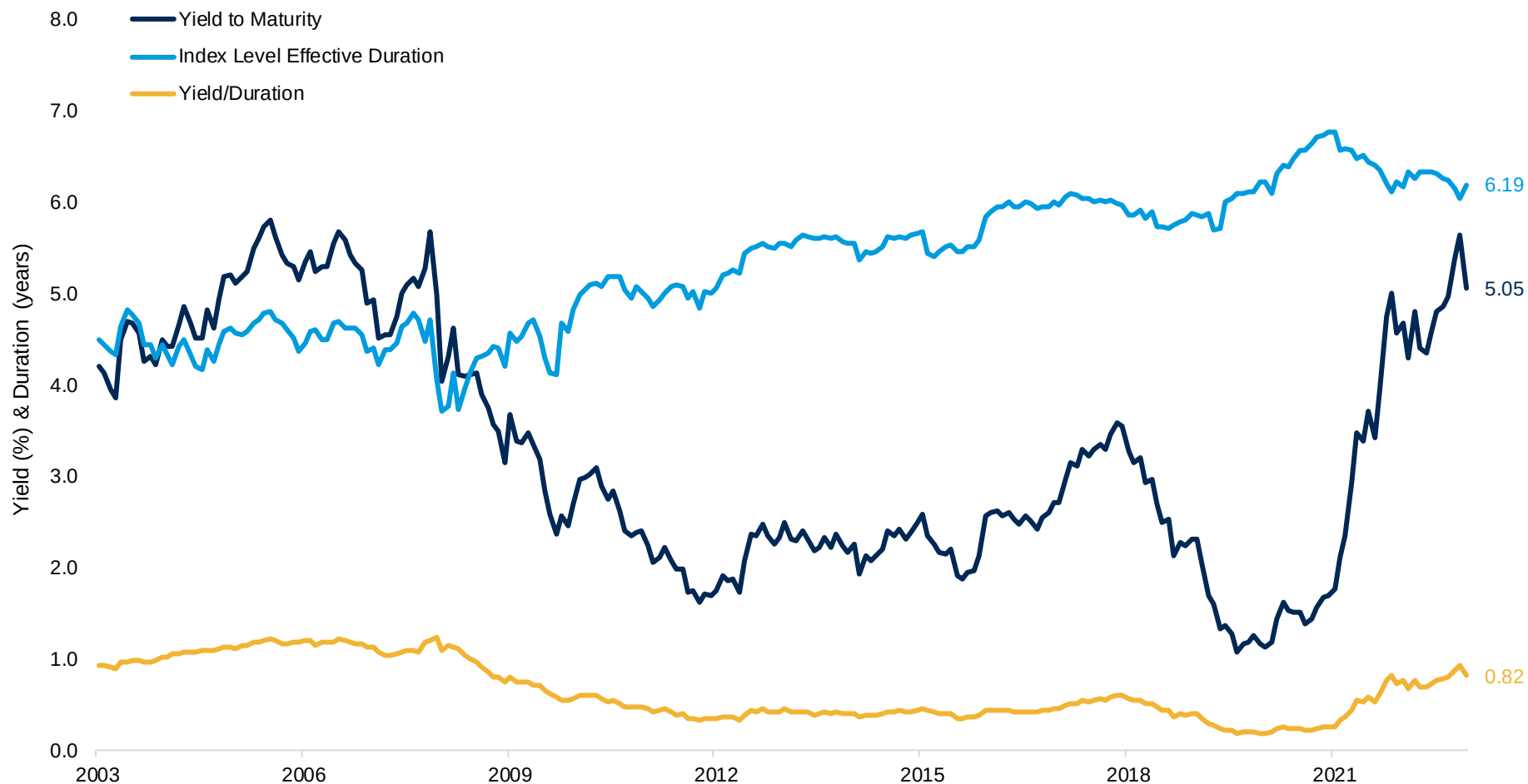

Bloomberg US Aggregate Bond Yield and Duration

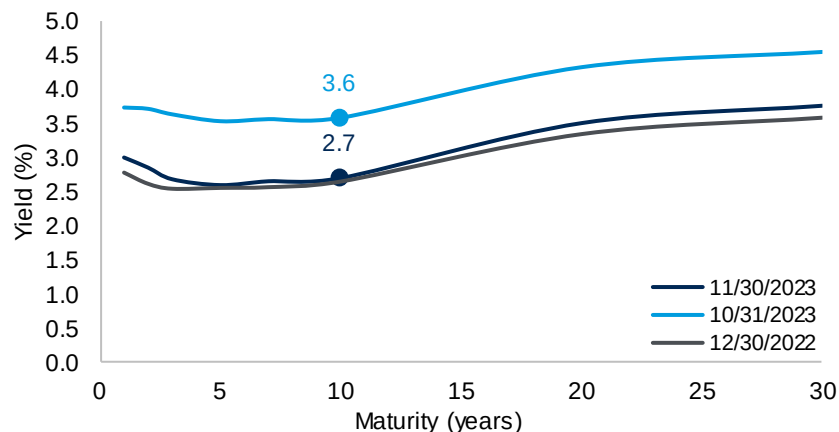

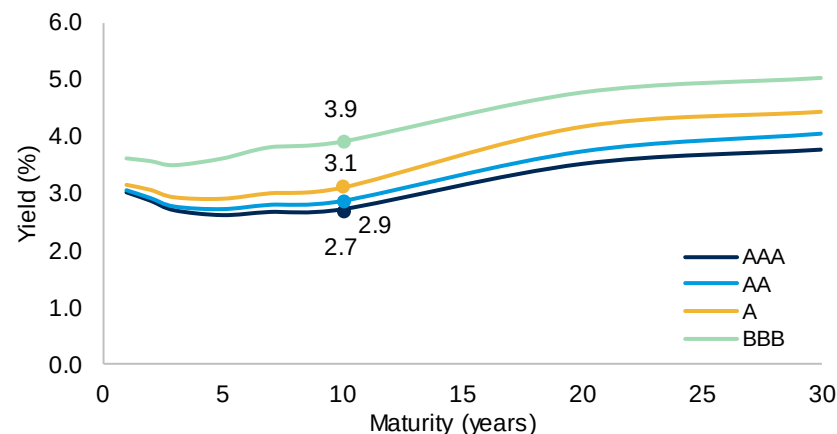


S&P AAA Muni Yield Curve



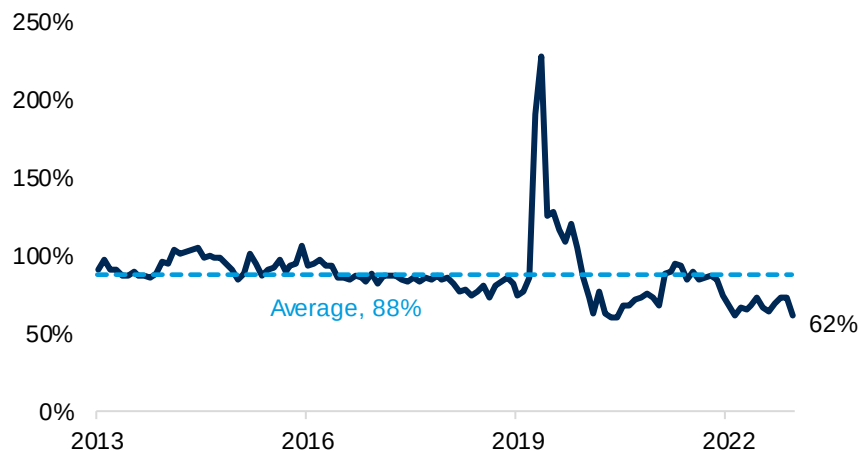

S&P U.S. Muni Curves



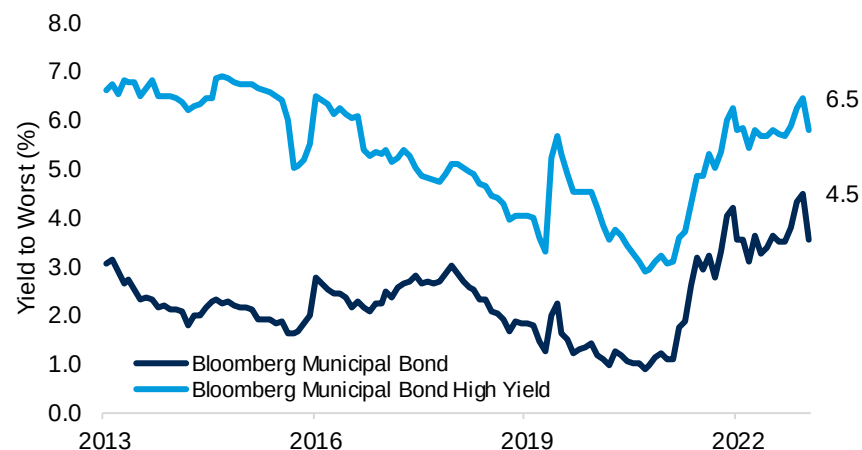

Treasury Yields and Subsequent Fixed Income Performance

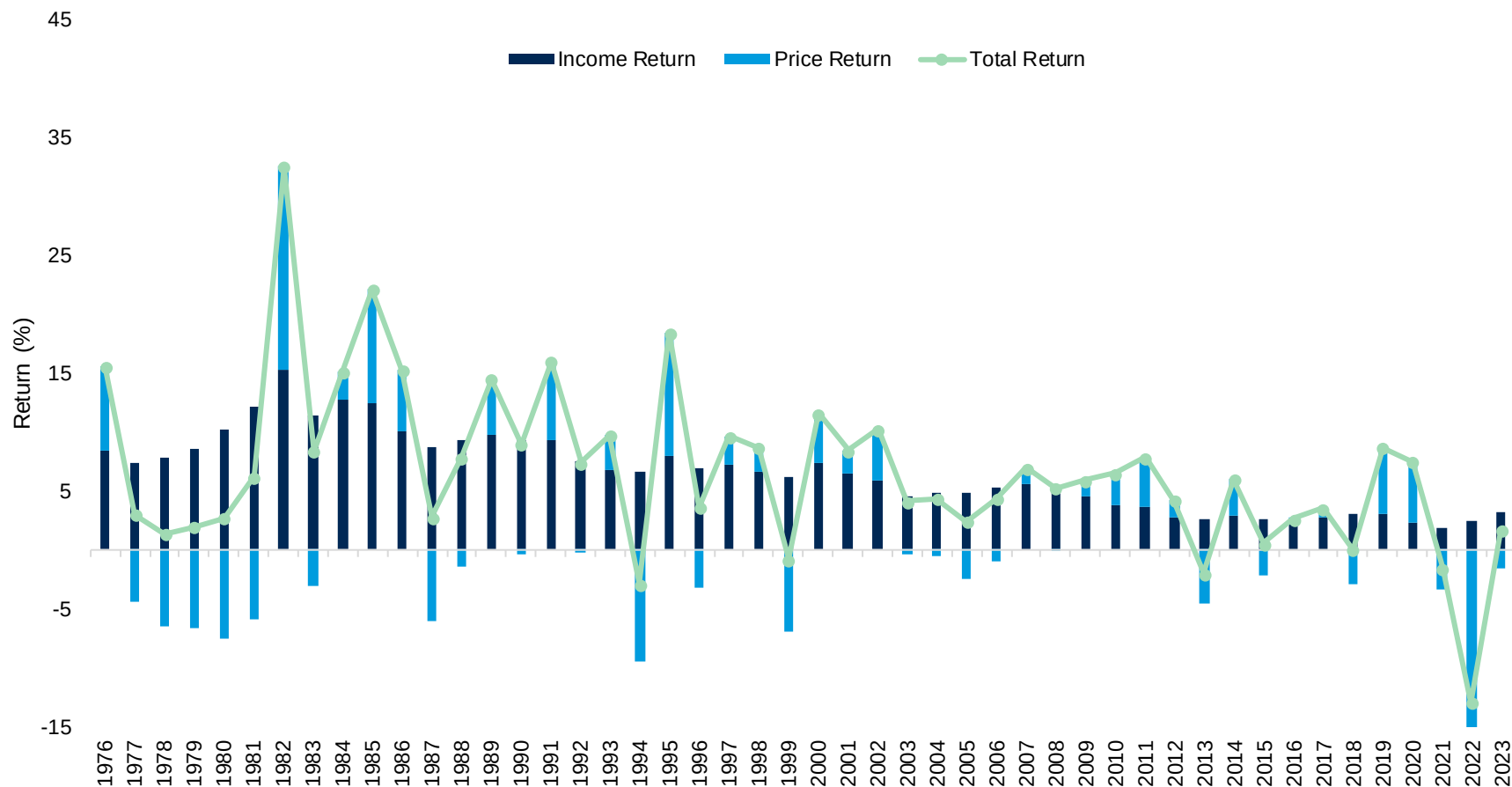

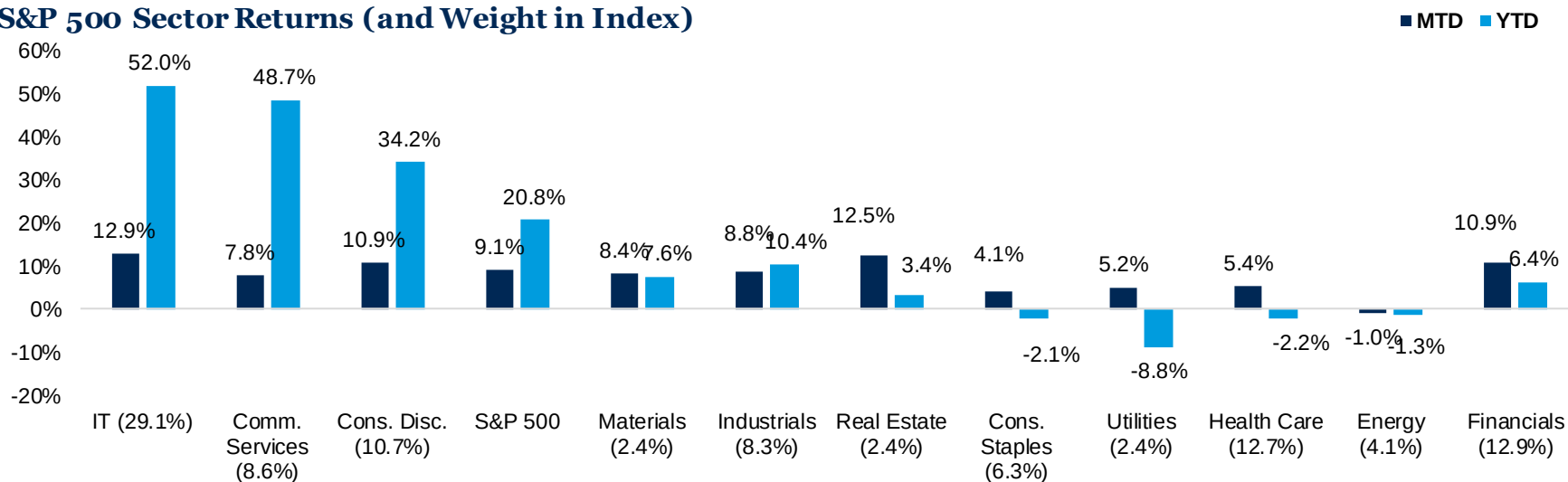

S&P 500 Sector Returns (and Weight in Index)



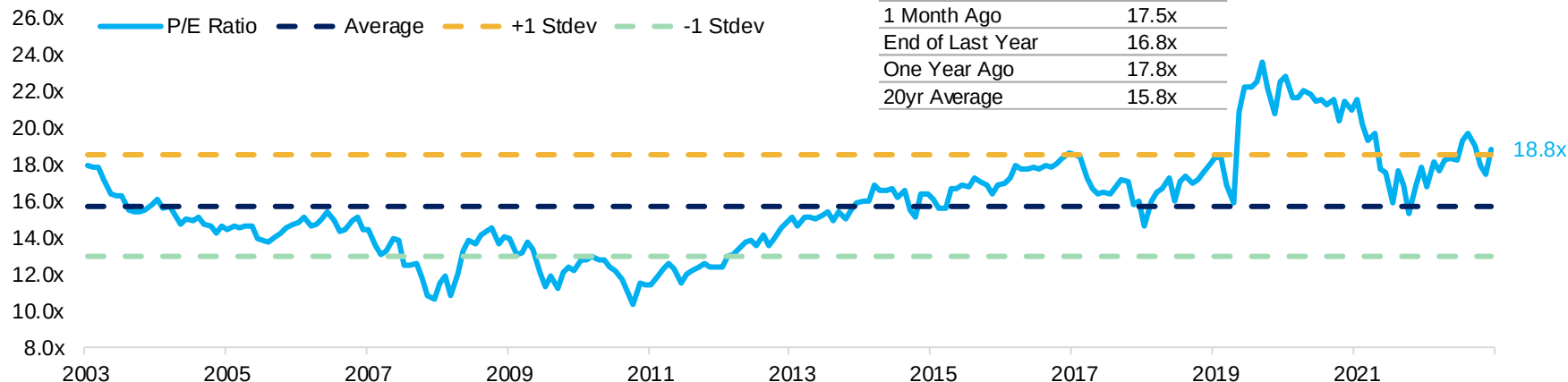

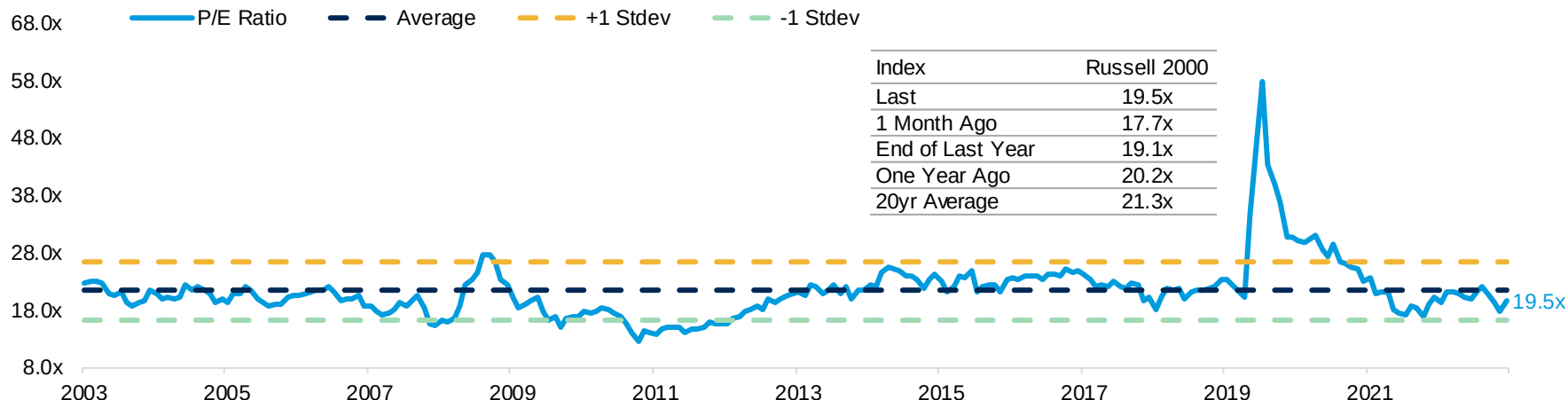


S&P 500 - P/E Ratio

Russell 2000 - P/E Ratio



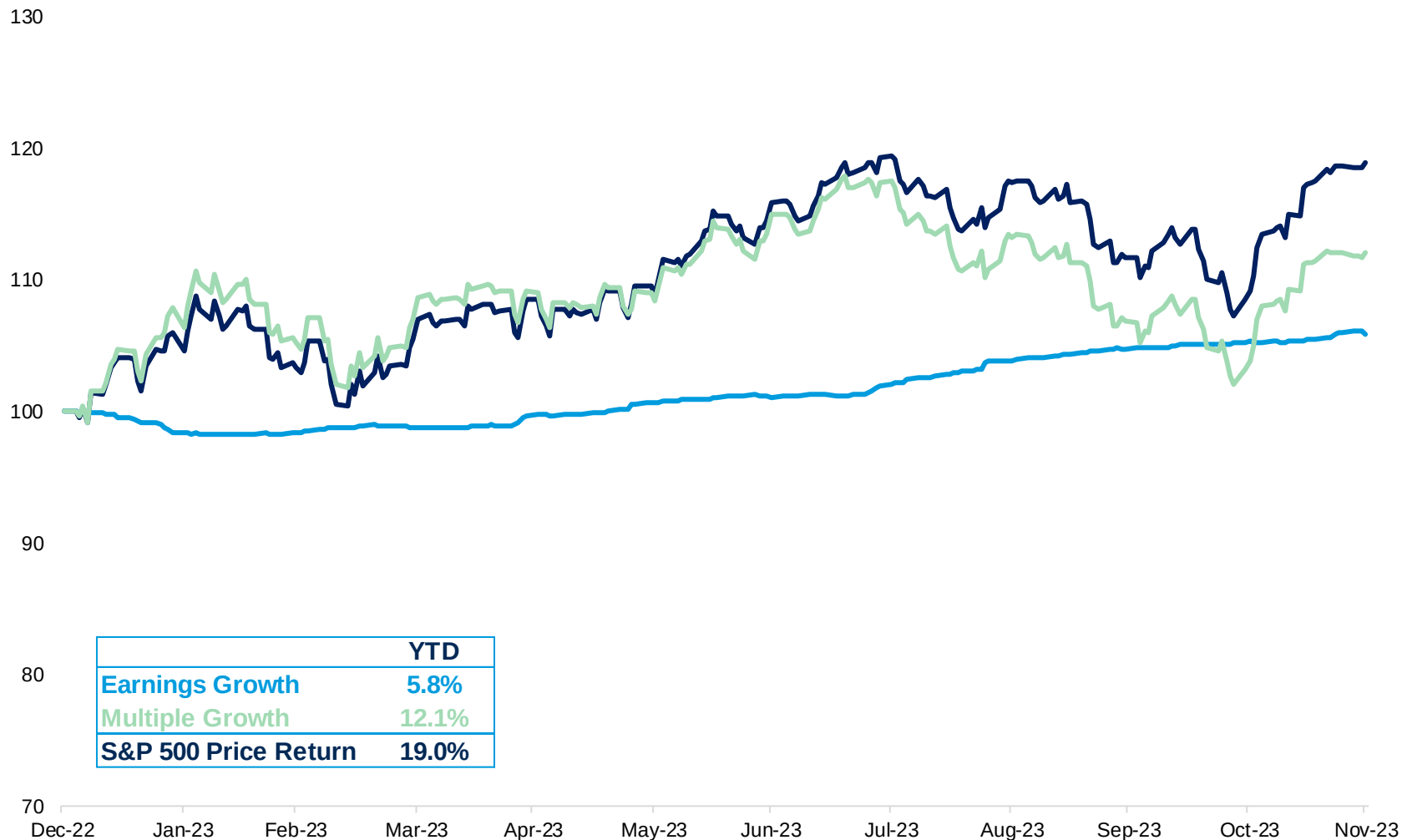

S&P 500 Earnings Decomposition



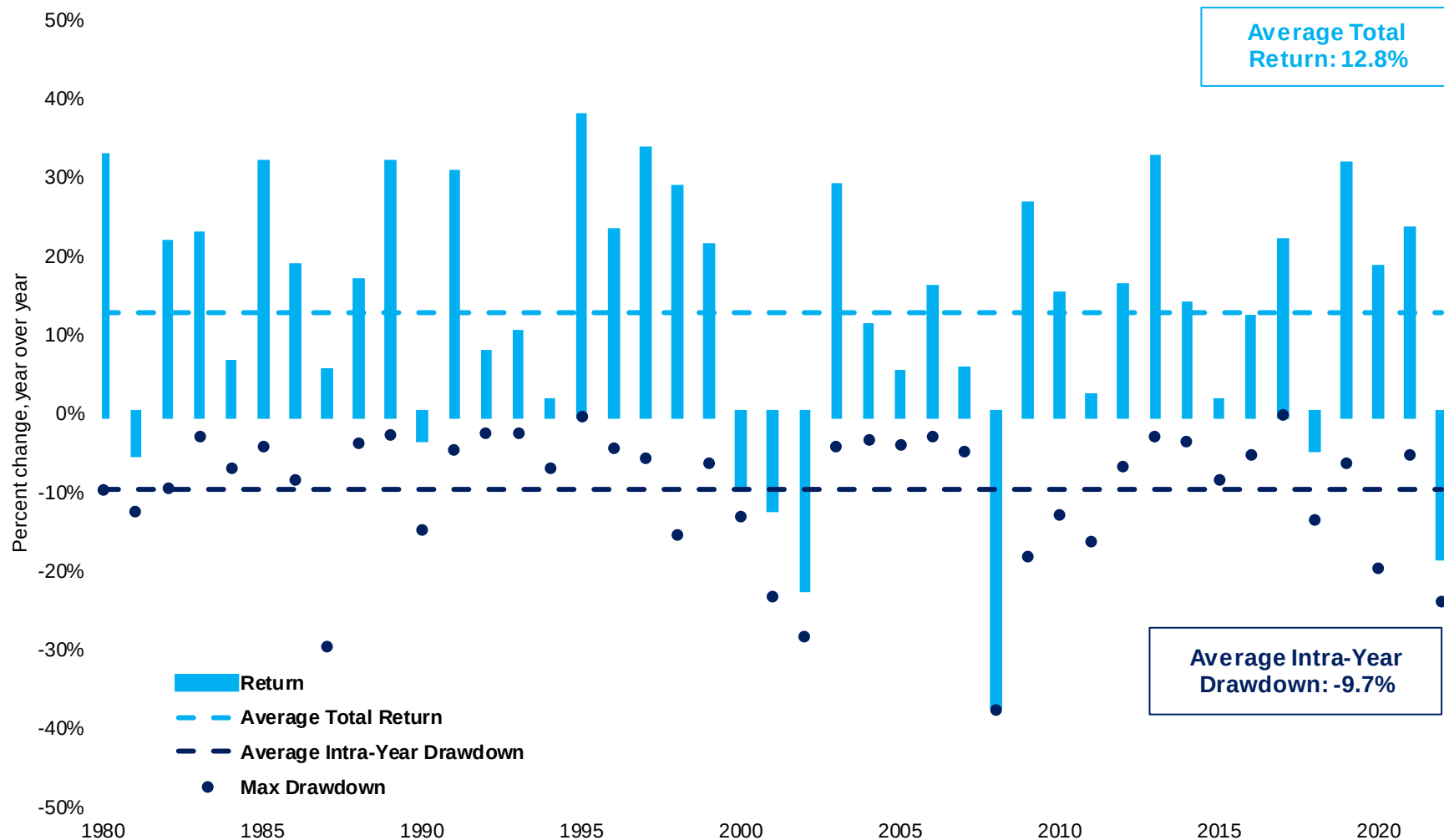

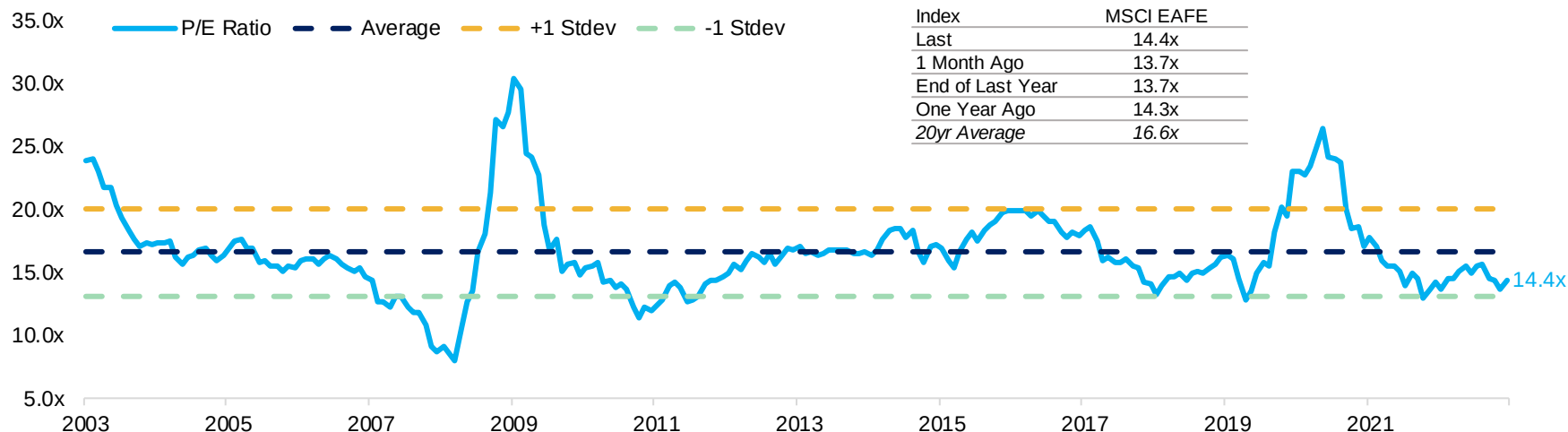

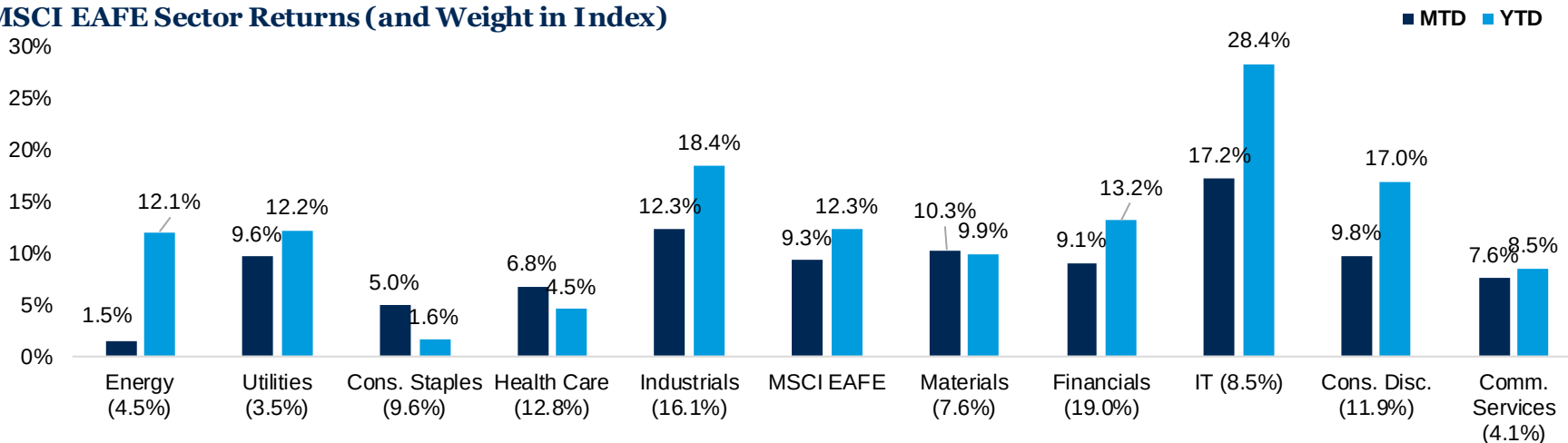


MSCI EAFE - P/E Ratio

MSCI EAFE Sector Returns (and Weight in Index)



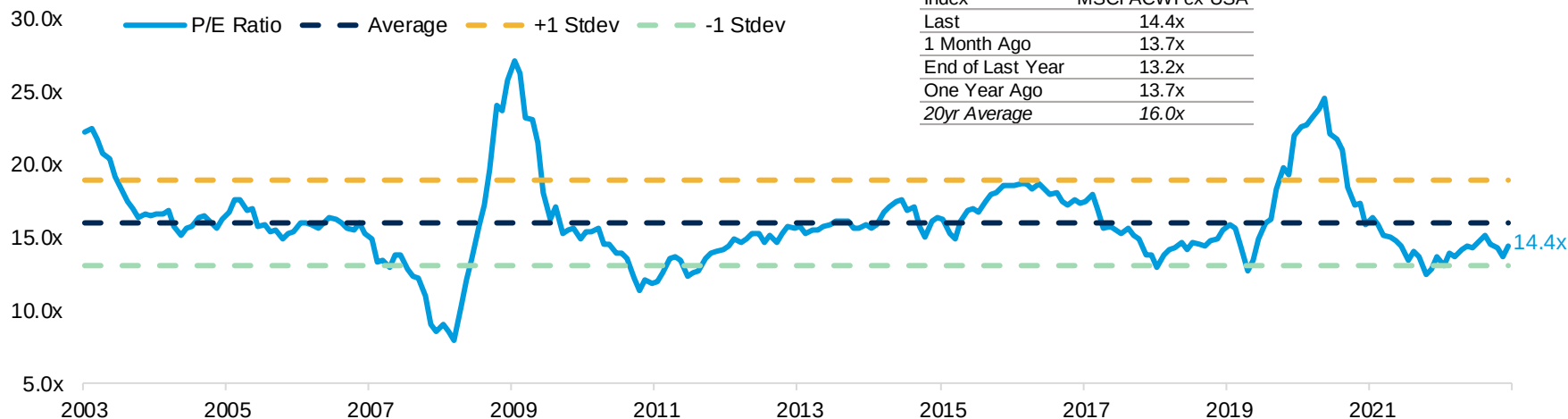

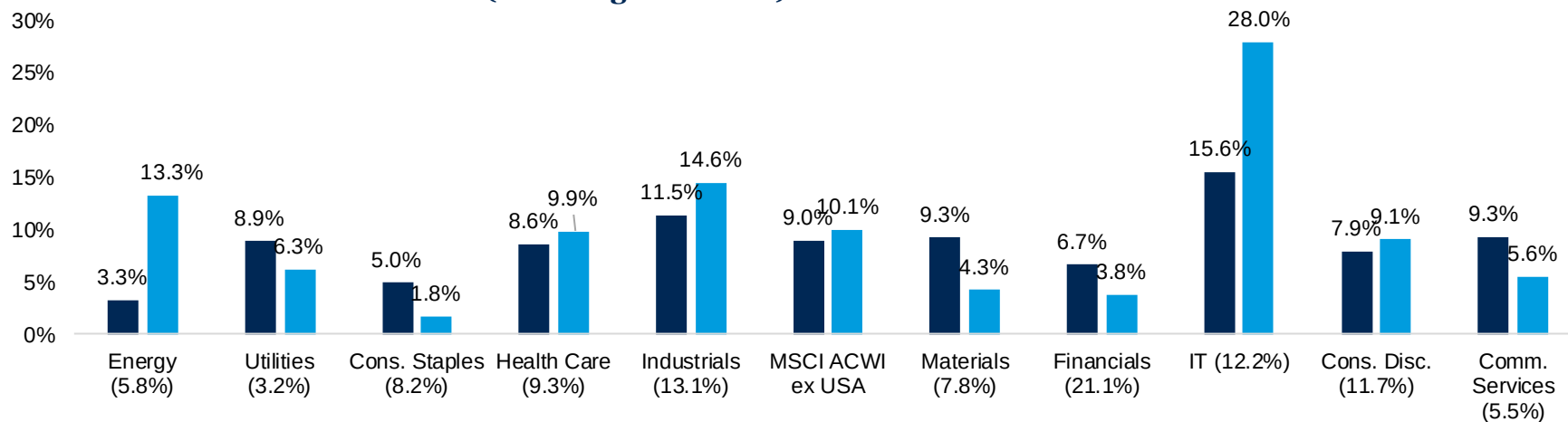


MSCI ACWI ex USA - P/E Ratio

MSCI ACWI ex USA Sector Returns (and Weight in Index)



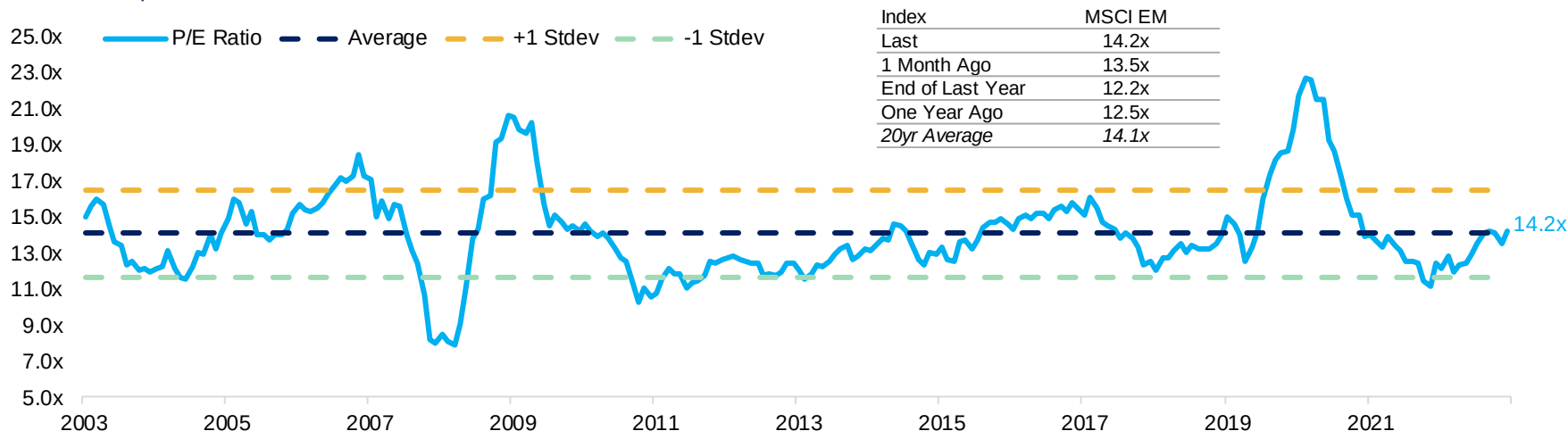

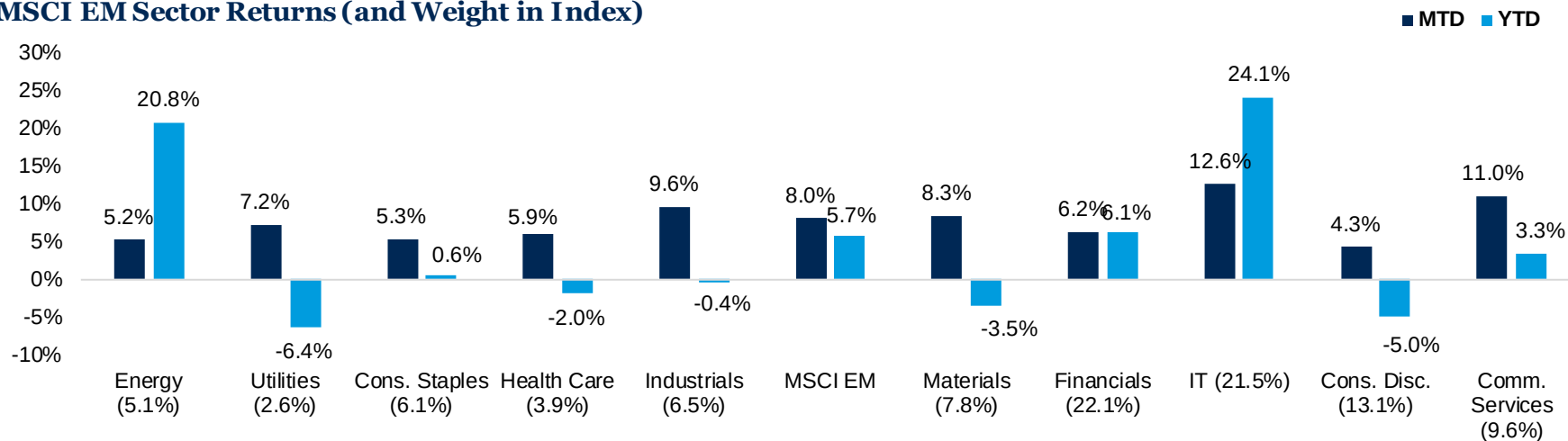


MSCI EM - P/E Ratio

MSCI EM Sector Returns (and Weight in Index)



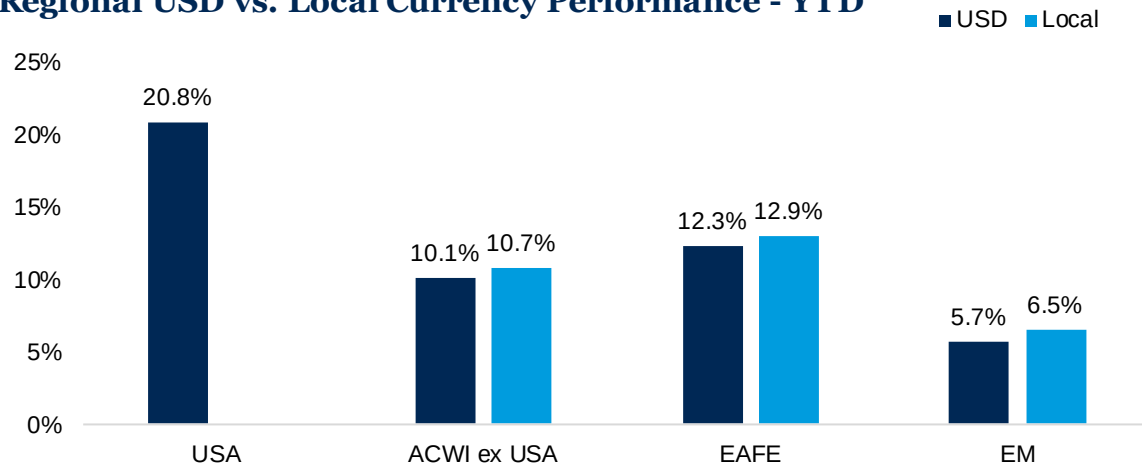

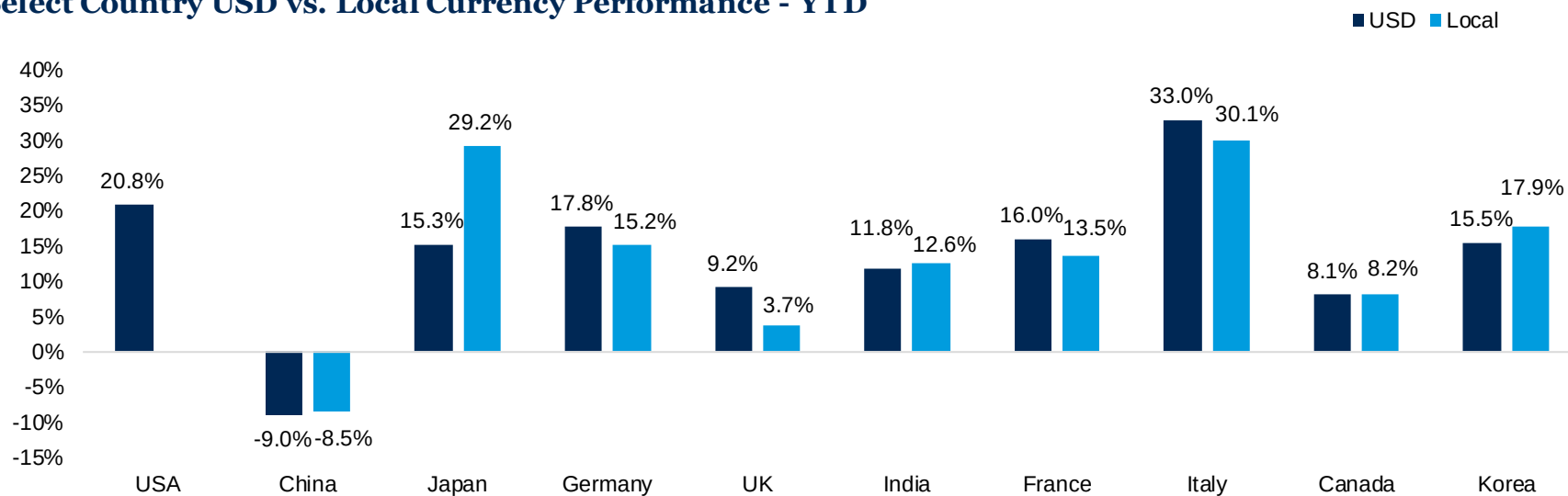


Regional USD vs. Local Currency Performance - YTD

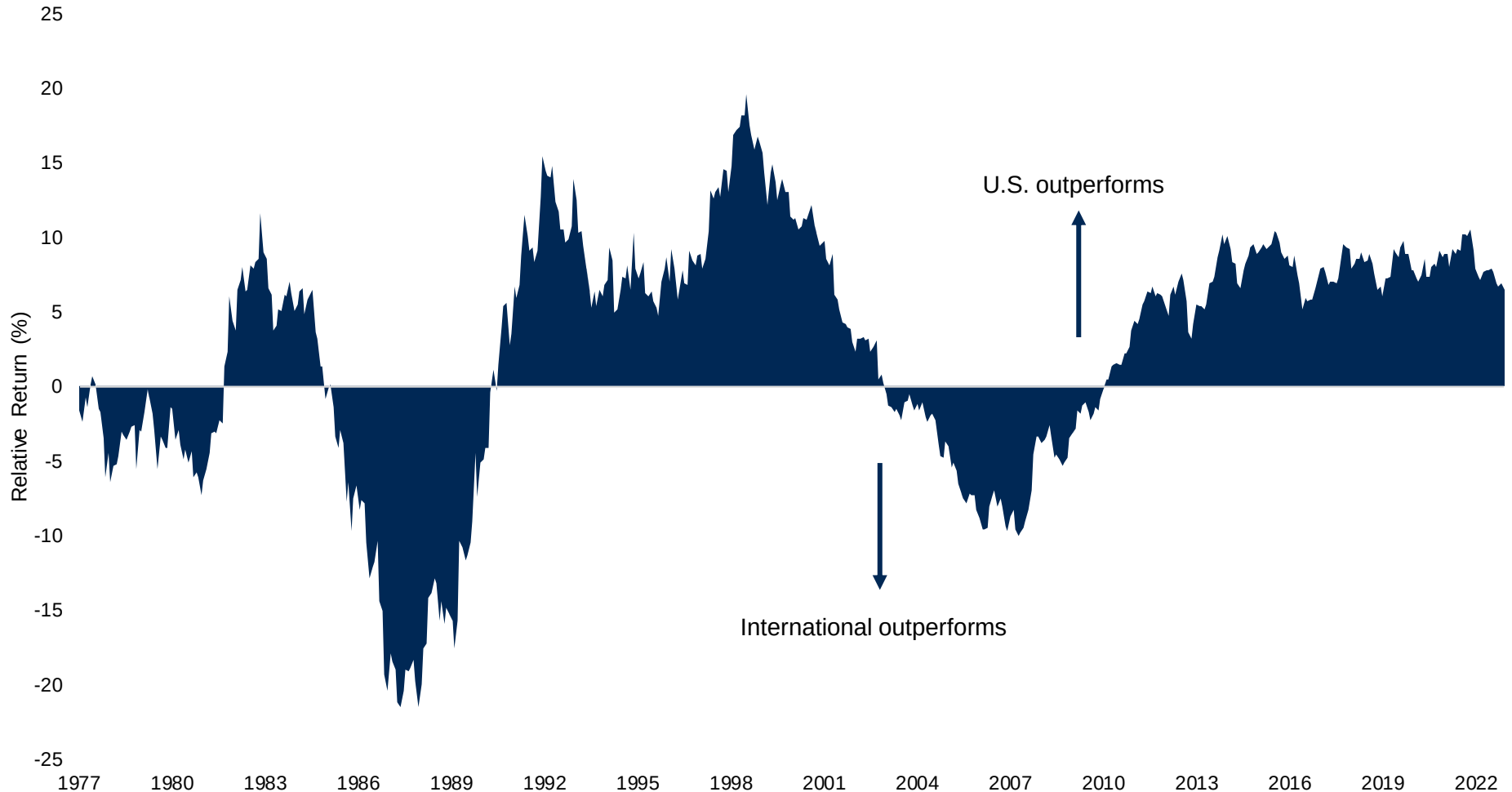

U.S. vs. International - Rolling 5-Year Relative Performance

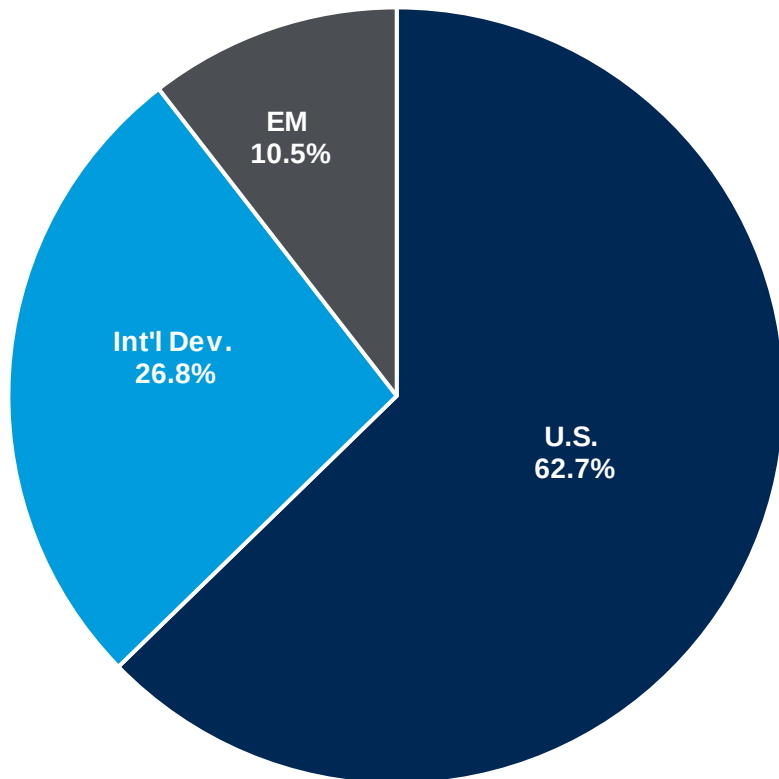

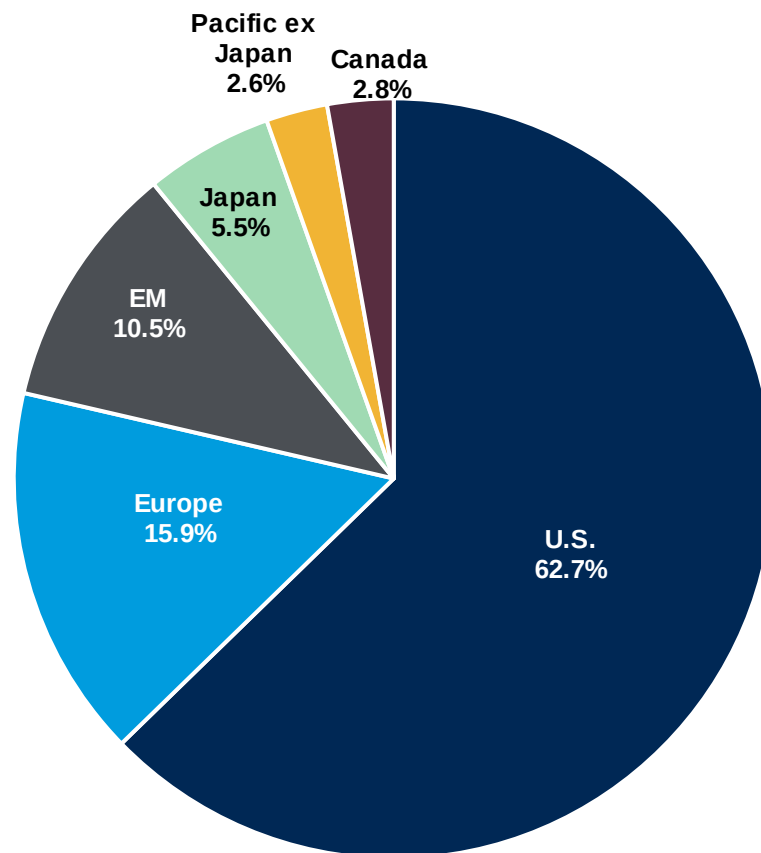


MSCI AC World Index Regions

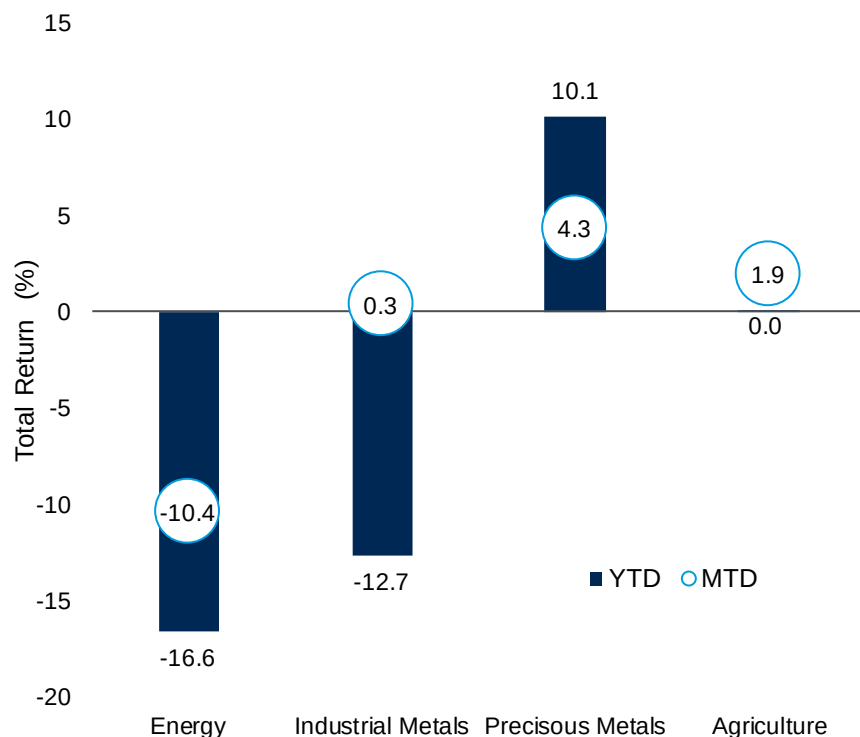

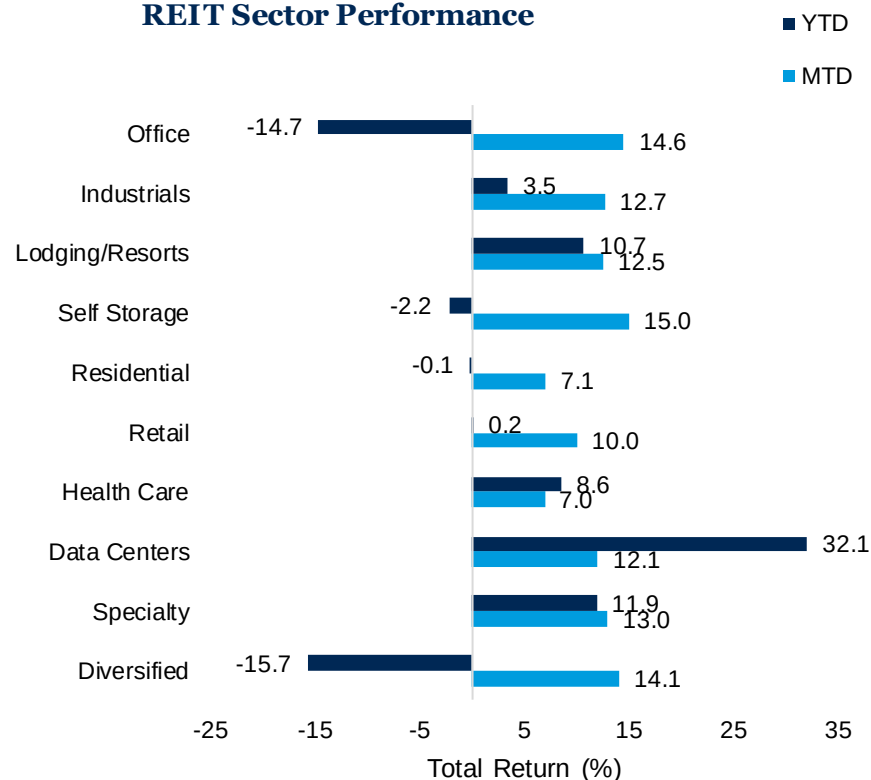

REIT Sector Performance



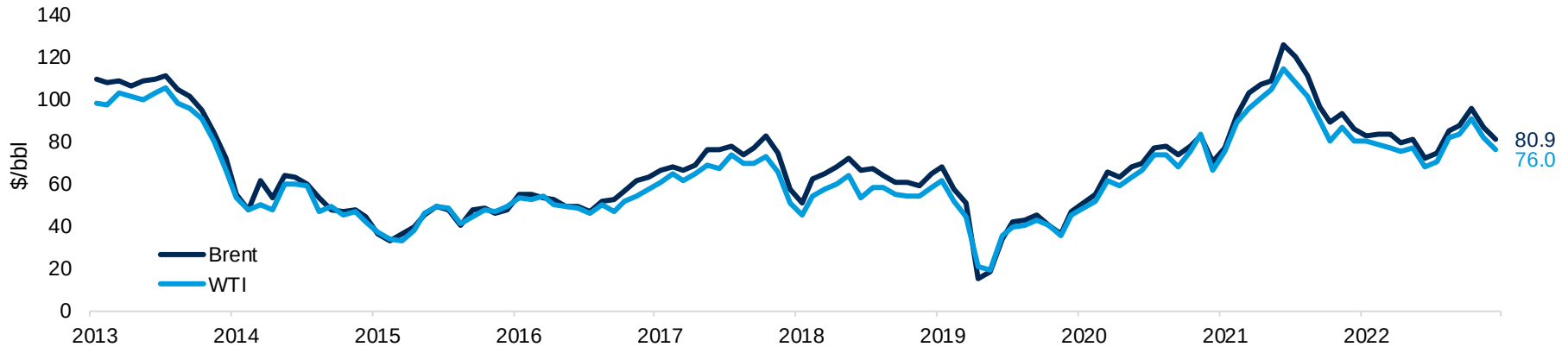

Fixed Income

- **Bloomberg 1-3 Month U.S. Treasury Bill Index** is designed to measure the performance of public obligations of the U.S. Treasury that have a remaining maturity of greater than or equal to 1 month and less than 3 months.
- **Bloomberg U.S. Aggregate Index** covers the U.S. investment grade fixed rate bond market, with index components for government and corporate securities, mortgage pass-through securities, and asset-backed securities.
- **Bloomberg Global Aggregate ex. USD Indices** represent a broad-based measure of the global investment-grade fixed income markets. The two major components of this index are the Pan-European Aggregate and the Asian-Pacific Aggregate Indices. The index also includes Eurodollar and Euro-Yen corporate bonds and Canadian government, agency and corporate securities.
- **Bloomberg U.S. Corporate High Yield Index** covers the universe of fixed rate, non-investment grade debt. Eurobonds and debt issues from countries designated as emerging markets (sovereign rating of Baa1/BBB+/BBB+ and below using the middle of Moody's, S&P, and Fitch) are excluded, but Canadian and global bonds (SEC registered) of issuers in non-EMG countries are included.
